## To Potential Team Sponsors:

The NorCal Lawmen Football Organization, a federally registered 501(c)(3) non-profit organization, is currently seeking sponsorship donations for the Spring 2010 Northern California Football League (NCFL) Season. Since the 2008 season, the NorCal Lawmen have been working directly with Children's Hospital Oakland and the team is giving 10% of all sponsorship donations of \$500 or more directly to the hospital, as well as 10% of all team proceeds at home games. Lawmen players and staff members also volunteer at Children's Hospital Oakland fund raising events throughout the year. Over 50% of our entire team budget currently also goes directly to California public schools to rent our practice and playing fields. The Lawmen won the Golden Coast Football League (GCFL) championship with a 12-1 record in 2006, and ended up losing the 2008 GCFL Championship game in the last few minutes, finishing 2008 with a 10-3 record. The Lawmen have appeared in the league title game six times in the last eleven years, winning four titles, including the California State Title in 2002. Over the past twelve years, the Lawmen have gained national recognition through our success on the field and our commitment to the community.

Our team goal for 2009 is to obtain the sponsorship donations that will enable us to compete for the NCFL championship while providing the community with quality football entertainment. And, to help the kids at Children's Hospital Oakland through the donation of time and money. Sponsoring the Lawmen can benefit your company through our growing fan base, highly successful Web presence, local community involvement and national recognition. This partnership would allow us to build our fan base and attract top players through team marketing, promotions, giveaways, community events, and special events at home games. ## Sponsorship and Donation Policies and Usage

The Lawmen accept sponsorship donations from all types and sizes of business, large and small. These donations typically range from \$250 to \$7,500. We are a federally registered non-profit organization EIN 37-1532234 (CA State ID: [C2793470](#)).

The Lawmen give 10% of all sponsorship donations of \$500 and above, directly to Children's Hospital Oakland, along with 10% of all home game proceeds. Lawmen players and staff members volunteer at Children's Hospital Oakland fund raising events throughout the year. Over 50% of our entire team budget currently also goes directly to California public schools to rent our practice and playing fields. All of our current team staff, including management, coaches, team assistants and training staff members work for us on a volunteer basis.

The sponsorship donations are used to build the organization and pay team expenses as follows:

- Pay league and game fees: Fees are required to participate in the various football leagues and each game requires fees to pay for the referees and sometimes other game related expenses
- Rent practice and game facilities including fields, locker rooms, security, janitors, and lights for night games, etc.
- Promote youth organizations and high school athletes for exceptional performances and academic achievement
- Purchase medical training equipment and supplies
- Pay team travel expenses
- Purchase football equipment
- Purchase Lawmen team merchandise including hats, jackets, shirts, sweat shirts, etc. to be used by the team players and staff, sold from our Website and at our games and given away at special events and promotions
- Purchase team and sponsor banners and signs
- Pay for printing and design services for team programs, posters, fliers and other Lawmen marketing collateral
- Help build our world class Web presence
- Make charitable donations to various organizations

## Building Community Relationships

The Lawmen team prides itself on creating maintaining relationships with the local community and working with kids. The following are some of the major accomplishments that the Lawmen have made in this area over the past few seasons. Our plan for 2010 is to gain enough sponsorships to allow us to further excel in this area through charitable donations and community events.

- Children's Hospital of Oakland: The Lawmen donate 10% of all team proceeds at home games, as well as 10% of all sponsorship donations of \$500 or more, directly to Children's Hospital Oakland. Players and staff members from our team also volunteer at hospital fund raising events throughout the year.
- AIDS Walk of San Francisco: Players and coaches actively participate in the walk and our team helps sponsor them in the walk through donations.
- Martinez Youth Football - Punt, Pass and Kick Events: We work together with the Martinez Youth Football to put together this event, and they hold their punt, pass and kick competition finals during half time at a Lawmen home game each season.
- California PAL (Police Activities League): We actively support this youth athletic program through team donations.
- Benicia High School Sports: When it was announced in 2003 that the Benicia High School athletes would have to pay their own way to maintain sports programs at their school, the Lawmen began actively helping their football program to raise money so that the kids could continue the tradition of football at their school.
- Antioch High School Sports: Volunteers from our team work as coaches and perform other needed duties for the Antioch High School sports program.
- Berkeley Jr Bears Youth Football Organization: The Lawmen have donated their time and assets to the Berkeley Jr. Bears to create and update the organization's website at <http://www.berkeleyjrbears.com>.
- The team is currently working on a proposal to open up a youth center in Oakland.

## Team Success

If you review our Website at <http://www.lawmenfootball.org>, you can quickly see that we are successful both on the field and off the field. In the last few years, we have had the following major accomplishments outside of just winning football games:

- On the field the Lawmen have a record of 116 Wins and 40 losses since 1997 and have scored 3910 points while only allowing 1738, winning four League championships and one California State Championship during that period.
- The Lawmen have been covered in news stories by KRON 4 TV, KCBS News Radio 740 and the Oakland Tribune. There are links to each of these on our Website.
- Oakland Raiders Head Coach Norv Turner visited our practices in 2005
- We held our first annual Pro-Player Autograph night in 2005 featuring Former All-Pro Oakland Raiders tight end Raymond Chester and Former All-Pro Oakland Raiders defensive end Art Thoms among others.
- Lawmen Offensive Lineman Randy Moore starred in an Outback Steakhouse TV commercial with John Madden in 2004. A link to this video clip is posted on the home page our Website.
- Multiple Lawmen players have moved on to professional football leagues
- Chuck Muncie, the former NFL Pro Bowl MVP and Heisman Trophy runner up at CAL University helped coach the Lawmen running backs and offense in 2004
- Lawmen Kicker Mike Gianni kicked a record breaking 53 yard field goal in 2003, gaining national recognition.
- In 2003, the Lawmen announced Tom Kano, the Bay Area renowned Chiropractor, as team Medical Director. Tom still serves in this role, along with head trainer Akash Rajan D.C. and a complete medical training staff to support the Lawmen team at all games, home and away.
- In 2006, the Lawmen were 12-1 in GCFL league play and won the GCFL title. The team then moved on to compete in the MLFA national championships, finishing 2006 with a 15-4 overall record and losing a very close battle 17-20, missing a 42 yard game-tying field goal with 2 seconds on the clock in the MLFA national semi-finals.
- In 2008, the Lawmen finished 10-3. Finishing second in the GCFL after losing the lead in the championship game with less than 7 minutes left in the 4<sup>th</sup> quarter.
